**ACKNOWLEDGEMENT OF RISK AND HOLD HARMLESS AGREEMENT**  
I HEREBY ACKNOWLEDGE THAT I HAVE VOLUNTARILY CHOSEN TO USE THE FACILITIES AND PARTICIPATE IN THE ACTIVITIES AT ROCK CREEK YOUTH CAMP, 4606 EAST ROCK CREEK ROAD NORMAN, OK 73071. THIS INCLUDES, BUT IS NOT LIMITED TO THE CHAPEL, THE FIELDS, THE TRAILS, THE POND, THE KITCHEN AND DINING AREA, CABINS AND BATH HOUSES (HEREINAFTER CALLED "THE CAMP").

I UNDERSTAND THE RISKS INVOLVED IN THE CAMP. I RECOGNIZE THAT THE PROGRAMS AND ITS ACTIVITIES INVOLVE RISK OF INJURY AND I AGREE TO ACCEPT ANY AND ALL RISKS ASSOCIATED WITH IT, INCLUDING BUT NOT LIMITED TO PROPERTY DAMAGE OR LOSS, MINOR BODILY INJURY, SEVERE BODILY INJURY AND DEATH. I AM VOLUNTARILY PARTICIPATING IN THE VISIT TO THE CAMP WITH THE KNOWLEDGE OF RISKS INVOLVED AND HEREBY AGREE TO ACCEPT ANY AND ALL INHERENT RISKS OF PROPERTY DAMAGE, BODILY INJURY OR DEATH.

IN CONSIDERATION OF MY PARTICIPATION IN THE VISIT TO THE CAMP AND TO THE FULLEST EXTENT PERMITTED BY LAW, I AGREE TO: INDEMNIFY, DEFEND AND HOLD HARMLESS ROCK CREEK YOUTH CAMP, ITS BOARD MEMBERS, VOLUNTEERS AND STAFF MEMBERS FROM AND AGAINST ANY AND ALL CLAIMS ARISING OUT OF OR RESULTING FROM MY PARTICIPATION IN THE VISIT. IN ADDITION, I HEREBY VOLUNTARILY HOLD HARMLESS ROCK CREEK YOUTH CAMP, ITS BOARD MEMBERS, VOLUNTEERS AND STAFF MEMBERS FROM AND AGAINST ANY AND ALL CLAIMS, BOTH PRESENT AND FUTURE, THAT MAY BE MADE BY ME, MY FAMILY, ESTATE, HEIRS OR ASSIGNS.

I HEREBY EXPRESSLY AGREE TO INDEMNIFY, DEFEND AND HOLD HARMLESS ROCK CREEK YOUTH CAMP, ITS BOARD MEMBERS, VOLUNTEERS AND STAFF MEMBERS FOR ANY CLAIM ARISING OUT OF OR INCIDENT TO MY PARTICIPATION IN THE CAMP, UNLESS CLAIM IS CAUSED BY THE SOLE NEGLIGENCE OR WILLFUL MISCONDUCT OF ROCK CREEK YOUTH CAMP, ITS BOARD MEMBERS, VOLUNTEERS AND STAFF MEMBERS.

I ALSO UNDERSTAND THAT ROCK CREEK YOUTH CAMP, ITS BOARD MEMBERS, VOLUNTEERS AND STAFF MEMBERS DOES NOT PROVIDE ANY MEDICAL OR DENTAL INSURANCE OR LIFE INSURANCE TO COVER BODILY INJURY, ILLNESS OR DEATH, NOR INSURANCE FOR PERSONAL PROPERTY DAMAGE OR LOSS, NOR INSURANCE FOR LIABILITY ARISING OUT OF MY NEGLIGENT ACTS OR OMISSIONS; AND I ACKNOWLEDGE THAT I AM COMPLETELY RESPONSIBLE FOR MY OWN INSURANCE TO COVER THESE EXPENSES.
